ARTICLE I. NAME

The name of the club shall be Lincoln Hills Cyclists herein referred to as "LHC".

The name of the association is Sun City Lincoln Hills Community Association and herein referred to as "SCLHCA"

ARTICLE II. PURPOSE

1. LHC is organized and will operate in full compliance with the Association's governing documents, including the SCLHCA club Information & Guidelines Handbook.
2. LHC is a non-profit, tax exempt, recreational organization serving and supporting cyclists living in Sun City Lincoln Hills and their guests.
3. The purpose of the LHC is to provide cycling rides and routes geared toward building strength, stamina and endurance while having fun and enjoying the flora and fauna of our diverse community.
4. The group maintains a website, contributes articles to the SCLH Compass, Lincoln News Messenger and Sun Senior News, hosts social events and supports various community, City, County and State bicycle related activities, events and organizations.

ARTICLE III. MEMBERSHIP

All residents of Sun City Lincoln Hills are welcome to join the LHC. Each household membership in good standing shall be entitled to one (1) vote. Household membership in good standing shall be defined as those whose dues are current and who have filled out a membership application form to be retained on file by the LHC Secretary/Treasurer.

Any member or officer in violation of the rules of the Shared Interest Group Guidelines will be suspended from the LHC.

ARTICLE IV. MEETINGS

Members will be provided advance notice for the time and location of all LHC meetings.

ARTICLE V. VOTING

The Board of Directors will be elected by LHC general membership.

ARTICLE VI. FINANCIAL AUTHORITY

The Secretary/Treasurer has responsibility for financial transactions. Both the Secretary/Treasurer and the President are to be authorized signers on the LHC bank account(s).

ARTICLE VI. RECORDS AND REPORTS

LHC is responsible for internal financial transactions and records, including any tax responsibilities, and has the responsibility to report appropriate financial business to its members.

1. All LHC governing documents, meeting minutes, and financial records must be available for review by any LHC member in good standing.
2. The LHC will maintain a current list of at least two LHC contacts with phone numbers and email addresses and submit it to the SCLHCA Room Booking and the SCLHCA Club Coordinator.
3. Lists containing LHC member information shall not be used for commercial, political or personal purposes not related to the business of the LHC.

ARTICLE VII. LHC DISSOLUTION

In the event that the LHC dissolves, all remaining assets will be either returned to LHC members or donated to a charitable organization. Dissolution will not be initiated until all outstanding debts are satisfied. Upon dissolution or abandonment of recognized LHC status, LHC should notify the SCLHCA Lifestyle staff of its reasons for dissolution or status abandonment.

ARTICLE VIII. AMENDMENTS

Bylaw amendments must be approved by LHC's general membership prior to being submitted to the CCOC for review and recommendation to the Association's Board of Directors for approval. They will become effective after final approval by the Association's Board of Directors (BOD).
